Required plans must be submitted before a permit can be issued.

V. Completing Application

General: Any regulated activity started prior to the applicant securing the permit will be charged an additional administrative fee at the same rate as the required permit fee, not to exceed \$100.00. This shall be paid prior to the issuance of the required permit. All work shall be in compliance with the mechanical code currently in effect. No work shall be concealed until it has been	Expiration of Permit: A permit remains valid as long as work is progressing and inspections are requested and conducted. A permit shall become invalid if the authorized work is not commenced within six months after issuance of the permit or if the authorized work is suspended or abandoned for a period of six months after the time of commencing the work. A permit will be cancelled when no inspections are requested and conducted within six (6) months of the date of issuance or the date of a previous inspection. Cancelled permits cannot be refunded or reinstated.

VI. Fee Clarifications

The application fee is **NON-REFUNDABLE** and **DOES NOT** include any inspections.

For new houses, items #1, #2, #41, and #42 are required. All inspections are separate fees.

Items #3a and #5b Furnace Replacement and Water Heater Replacment are flat rates of \$125.00. No application fee is needed.
